

Promotion Rules “SAVEMONEY”

§1. General provisions

1. The organiser of the promotion (hereinafter the “Promotion”) is Alasta Sp. z o.o., with its registered office at Niałek Wielki 106, 64-200 Wolsztyn, Poland, VAT ID (NIP): 9231732328 (hereinafter the “Organiser”).
2. The Promotion is conducted in the online store www.alasta.co.uk (hereinafter the “Store”).
3. Contact regarding the Promotion: shop@alasta.co.uk
4. Participation in the Promotion is voluntary and constitutes acceptance of these rules.

§2. Participants of the Promotion

1. The Promotion is available to consumers and businesses making purchases in the Store, subject to sections 2–8.
2. The Promotion does not apply to orders placed by customers with individual commercial terms, in particular permanent discounts, framework agreements or dedicated price lists (hereinafter “Customers with Individual Terms”).
3. Customers with Individual Terms are not entitled to the Promotion discount; if a discount has been applied, it may be cancelled prior to acceptance of the order for fulfilment.
4. The Organiser may refuse to apply or may cancel the discount if it follows from the order data that the purchaser is a Customer with Individual Terms.
5. The promotion code may be used a maximum of once (1) per Customer per Promotion edition.
6. A “Customer” is identified in particular by one or more of the following: Store account, e-mail address, telephone number, VAT number (NIP), delivery address or billing address.
7. In the event of attempts to circumvent the limits (e.g. using different data, creating multiple accounts or splitting purchases), the Organiser may refuse or cancel the discount.
8. The Promotion is not intended for purchases for resale or purely supply-related purposes.

§3. Duration and scope

1. The Promotion is time-limited. Information on its duration is provided in the Store or in promotional communications.
2. The Promotion applies to products available in the Store, subject to §7.

§4. Conditions of participation

1. To benefit from the Promotion, the Customer must enter a valid promotion code provided by the Organiser (hereinafter the “Code”) in the cart or at checkout.
2. Failure to enter the Code, incorrect entry or failure to meet the Promotion conditions results in no discount being applied.
3. The Code may be subject to restrictions (e.g. validity period, usage limits, product restrictions).

4. “Order value” means the total value of products in the cart (gross prices) before application of the Promotion discount, excluding delivery costs and any additional charges.

§5. Discount rules

1. After exceeding an order value of £400, the Store applies a discount of £50.
2. After exceeding an order value of £650, the Store applies a discount of £100.
3. If the £650 threshold is met, the £100 discount is applied as the discount applicable to the higher threshold.
4. The discount is applied automatically after entering the correct Code and meeting the order value thresholds.
5. Threshold discounts are not cumulative. Only one discount per order may be applied, corresponding to the highest threshold met.
6. Separate orders are not combined or aggregated for the purposes of meeting thresholds.

§6. Method of calculating the discount

1. The discount is a fixed monetary amount and reduces the total order value.
2. If, for technical reasons, the discount is proportionally allocated across products in the order, this does not affect the total discount amount.

§7. Products covered by the Promotion

1. As a rule, the Promotion applies to products available in the Store, unless expressly stated otherwise.

§8. Combination with other promotions

1. The Promotion may not be combined with other promotions, discounts or promotion codes unless the Store expressly states otherwise.

§9. Returns and withdrawal from the contract

1. In the event of withdrawal from the contract and return of the entire order, the Promotion discount is cancelled in full.
2. In the case of a partial return, the Organiser re-verifies whether the Promotion conditions are met, in particular the order value thresholds referred to in §5.
3. If the thresholds are no longer met after the return, the discount is cancelled; if a lower or higher threshold is met, the discount is adjusted accordingly.
4. These provisions do not limit the Customer’s rights under mandatory applicable law.

§10. Complaints

1. Complaints regarding the Promotion may be submitted by e-mail to: claim@alasta.co.uk
2. Complaints will be processed within 14 days of receipt.

§11. Final provisions

1. These rules enter into force on 23 February 2026.
2. The Organiser may terminate the Promotion early for important reasons (e.g. technical reasons) by publishing appropriate information in the Store.
3. Termination of the Promotion does not affect orders placed and confirmed for fulfilment prior to publication of the termination notice.
